- Terfynu Ysgol Trefriw, Ffordd Llanrwst, Trefriw, Conwy, LL27 0RX
- Sefydlu Ysgol Gynradd Cyfrwng Cymraeg newydd i'w chynnal gan Gyngor Bwrdeistref Sirol Conwy ar safle presennol Ysgol Dolgarrog, Ffordd Llanrwst, Conwy, LL32 8QE i fechgyn a merched 3 i 11 oed.

Mae'r Awdurdod wedi ystyried y cynnig a'r sylwadau a gyflwynwyd ac wedi ymateb yn unol ag anghenion Cod Trefniadaeth Ysgol 2013. Wrth benderfynu'r cynnig, roedd y Cabinet yn fodlon bod:

- Manteision y cynnig yn glir ac wedi'u cynllunio'n dda a bydd ansawdd a safon yr addysg y bydd disgylion yn ei gael yn parhau ac o leiaf yn cynnal y safonau presennol mewn amgylchedd Ysgol 21 Ganrif.

Mae'r rhesymau am y penderfyniad ynghylch y ffactorau a amlinellwyd yn y ddogfen ymgynghori yn unol â'r Cód Trefniadaeth Ysgol fel a ganlyn:

Bu Cyngor Bwrdeistref Sirol Conwy yn adolygu nifer y disgylion presennol, cydraddoldeb ariannu i ddisgylion ac addasrwydd i'r pwrras yr adeiladau ysgol presennol yn yr Awdurdod.

Dear Consultees

On 12 April, 2016 Conwy County Borough Council's Cabinet agreed the following proposal for the Caerhun and Trefriw Area –

- Discontinue Ysgol Dolgarrog, Ffordd Llanrwst, Conwy, LL32 8QE
- Discontinue Ysgol Tal y Bont, Conway Road, Tal y Bont, Conwy, LL32 8QF
- Discontinue Ysgol Trefriw, Llanrwst Road, Trefriw, Conwy, LL27 0RX
- Establish a new Welsh Medium Community Primary School to be maintained by Conwy County Borough Council on the current Dolgarrog School site, Ffordd Llanrwst, Conwy, LL32 8QE for boys and girls aged 3 to 11 year olds.

The Authority have considered the Proposal, the comments and observations submitted, and have responded in accordance with requirements of the School Organisation Code 2013. In determining the Proposal, Cabinet were satisfied that:

- The advantages of the proposal were clear and well planned and that the quality and standard of education pupils will receive will continue to at least maintain current standards in a 21st Century School environment.

The reasons for the decision in respect to the factors outlined in the published Consultation Document in accordance with the School Organisation Code are as follows:

Conwy County Borough Council has been reviewing current pupil numbers, equality of funding for pupils and the fitness for purpose of current school buildings across the Authority.

Ysgol Trefriw has xx%, Ysgol Tal y Bont, xx% and Ysgol Dolgarrog x% of unfilled places currently. As such in 2013 it was agreed to progress with the development one school on the site of Ysgol Dolgarrog in a new building.
