3. Mae'n rhaid cyflwyno papurau enwebu i'r Swyddog Canlyniadau (Gweithredol) ym MODLONDEB, CONWY, LL32 8DU ar unrhyw ddiwrnod ar ôl dyddiad yr hysbysiad hwn rhwng 10am a 4pm, ond heb fod yn hwyrach na **4pm ddydd Iau, 11 Mai 2017**.
4. Rhaid i bob ymgeisydd dalu ernes o £500 mewn arian neu ddrafft banc (banciau sy'n gweithredu yn y Deyrnas Unedig yn unig). Dylid gwneud drafftiau banc yn daladwy i Gyngor Bwrdeistref Sirol Conwy neu gyda chaniatâd blaenorol trwy daliad electronig.

Mae'n rhaid bod yr analluedd corfforol wedi digwydd ar ôl 5pm ddydd Mercher, 31 Mai 2017. ## UK PARLIAMENTARY ELECTION for the ABERCONWY CONSTITUENCY

1. An election is to be held for a Member of Parliament to serve the above-mentioned Constituency.
2. Forms of nomination may be obtained from the (Acting) Returning Officer at Bodlondeb, Conwy, LL32 8DU.
3. Nomination papers must be delivered to the (Acting) Returning Officer at BODLONDEB, CONWY, LL32 8DU on any day after the date of this notice between the hours of 10am to 4pm but no later than **4pm on Thursday, 11 May 2017**.
4. The deposit for each candidate of £500 must be paid in cash or by banker's draft (banks operating within the United Kingdom only). Banker's drafts should be made payable to Conwy County Borough Council or with prior permission by electronic payment.
5. If the election is contested the poll will take place on THURSDAY, 8 JUNE 2017.
6. Applications to be added to the register of electors in order to vote at this election must reach the Electoral Registration Officer at Bodlondeb, Conwy, LL32 8DU by Monday, 22 May 2017. Applications can be made online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).
7. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Bodlondeb, Conwy, LL32 8DU by 5pm on Tuesday, 23 May 2017.
8. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Bodlondeb, Conwy, LL32 8DU by 5pm on Wednesday, 31 May 2017.
9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Bodlondeb, Conwy, LL32 8DU by 5pm on 8 June 2017. The physical incapacity must have occurred after 5pm on Wednesday, 31 May 2017. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 31 May 2017.
