### **PROPOSED PUBLIC SPACES PROTECTION ORDER (PSPO) THE DONKEY PATH – COLWYN BAY**

As a resident or business owner in the area you may be aware of issues of anti-social behaviour which surrounds the area known as the Donkey Path, Colwyn Bay.

The problems reported are youths in groups behaving in a rowdy manner, causing serious nuisance and disturbance to residents, visitors and members of the public engaged in lawful activity in the area. North Wales Police, Conwy County Borough Council are jointly seeking measures to address this behaviour for the benefit of residents and visitors in the area.

In October 2014 the Anti-social Behaviour Crime and Policing Act 2014 was introduced. As part of this legislation comes the introduction of the Public Spaces Protection Order. This enables Local Authorities to impose prohibitions or requirements to specified areas to enable law abiding citizens to enjoy public areas without being affected by anti-social behaviour.

The new PSPO will introduce prohibitions and will hopefully deter the behaviour and enable Officers from North Wales Police to deal more robustly with offenders at the time of occurrence.

We are therefore contacting you as part of the required consultation process for the application for the enclosed proposed Public Spaces Protection Order for this area.




The consultation period will be open for 28 days from the 26<sup>th</sup> July 2017, the closing date for representations will be 23<sup>rd</sup> August 2017.
