1. The Proposal

This document outlines the proposal made by the Local Authority to enter a federation agreement with Ysgol Llanddoged and Ysgol Ysbyty Ifan in accordance with the Federation of Maintained Schools (Wales) Regulations (2014).

The aim of the Federation is for the schools to work in partnership. The Headteacher has provided the points below to outline the positive steps to date:

- Opening access to teaching expertise, up-skilling staff in both schools / share expertise / share good practice which ultimately raises standards and broadens experiences
- Allowing best practice, preparation materials and resources to be shared.
- Providing the best social opportunities for pupils
- Expand the professional development opportunities of staff in both schools.
- Allowing schools that federate to stay in their communities and keep their individual identity adding to the overall benefit, welfare, and achievement of all pupils
- Continue to strengthen the Welsh language, culture and ethos and ensure the distinct religious values of these church schools.
- Ensure the church values are strengthened between both schools

This will ensure significant positive outcomes and improved standards for all.

The term 'Federation' describes a formal and legal agreement by which a number of schools share governance arrangements. The key elements are:

- If the establishment of a School Federation is agreed, there will be a single governing body with strategic oversights of schools within Federation, the existing governing bodies will be dissolved and replaced by a new, single governing body with strategic oversight of both schools.
- Each School will retain their own character, name, category, budget, staff, and school uniform.
- The School will remain in its own community.
- Each School has its own Estyn inspection, though increasingly these are coordinated to happen at the same / similar time for all schools within the Federation to minimise stress and disruption.

The proposed name of the Federation is yet to be agreed.

We would like to know your views on this proposal and have suggested the ways in which you can do this at the end of this document.

Conwy recognises the importance of involving pupils of the schools in the development and improvement of their educational experience and with this in mind will ensure their active participation in the consultation process and implementation. Education Officers will consult with pupils and produce a children and young people's version of the consultation document and ensure that teachers hold sessions to discuss the proposal with pupils and encourage their engagement and feedback which will be shared with Cabinet.

2. Background and drivers for change

A federation can help small rural primary schools to remain sustainable within their communities. The shared governing body provides an effective and accountable mechanism for schools to pool resources and staff, gain economies of scale and efficiencies that enable them to remain viable. Smaller schools in more rural and isolated areas could also gain as federation could open opportunities to share management, governing body responsibility and curriculum expertise.

3. Overview of Ysgol Llanddoged and Ysbyty Ifan





Ysgol Llanddoged and Ysgol Ysbyty Ifan are 12.7 miles apart.

Both Ysgol Llanddoged and Ysgol Ysbyty Ifan are Voluntary Controlled, Church in Wales Primary Schools which provide Education for 3–11-year-olds from nursery up to year 6 pupils.

Welsh is the main language of both schools. Welsh is used as the language of communication with the pupils and for the school's administration. The school communicates with parents in both languages.

Church in Wales Schools' Ethos Statement

Recognising its historic foundation, both schools will preserve and develop religious characters in accordance with the principles of The Church in Wales and in partnership with the Church at parish and diocesan levels.

The school aims to serve the community by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith and promotes Christian values through the experience it offers to all its pupils.

4. Key Benefits and challenges presented by Federation

There are a number of key benefits and challenges presented by federation. The expected benefits and challenges of a small school proposal to federalise Ysgol Llanddoged and Ysgol Ysbyty Ifan have been considered by Education Services and are identified as shown in the table below:

5. Finance

The way in which an individual school's budget is calculated is not affected by federation - each school in the federation will continue to receive its own budget based on the number of registered pupils at the school plus any other contributing factors.

6. Leadership and Structure

Ysgol Llanddoged and Ysbyty Ifan currently have one Headteacher between both school sites.

Should the proposal to federate be implemented, the schools will have one executive Headteacher.

School had an assistant headteacher during the initial collaboration period. Sept 22 – Easter 24 to ensure that there was a site lead where the headteacher was not present.

7. The federation process

The process a local authority would use to federate schools is very similar to the one governing bodies would follow. If a local authority is considering federating a voluntary-

aided, voluntary-controlled or foundation school it should first contact the Charity Commission to discuss proposals. It must also obtain the consent of the relevant diocesan authority, trustees or persons who are responsible for appointing the foundation governors before continuing with the steps below. As part of Step 1 - the Exploration and Preparation phase, a letter was sent to the Diocese of St Asaph to seek their consent on a proposal to form a federation between both Schools. The Diocese responded to confirm that they are in support of exploring a federation proposal between these two schools and recognises the opportunities and benefits that a federation could offer the pupils and staff in both schools.

Local authorities should:

- consider federation as an option within their strategic plans for effective and efficient school provision in or across communities
- ensure that school organisation plans are sufficiently detailed and transparent to inform decisions about federation within and across school governing bodies
- consider the impact of their federation programme on voluntary-aided, voluntary-controlled and foundation schools where federation may not be easily achieved
- identify any small schools with fewer than 91 learners as the process of seeking the views of stakeholders to federate these small schools is shorter

The Education (Wales) Measure 2011 gave local authorities the power to make proposals for federation.

In the case of local authority-led federations, the decision whether to federate is made by the local authority after giving careful consideration to the use of federation as a strategic tool to drive improved outcomes and deliver resource efficiencies in their areas.

8. Composition of the Governing Body

The regulations require that each federated governing body should have a minimum of 15 Governors and a maximum of 27. We would initially look at having a fair representation from both schools on the new governing body.

9. Transport Impact

The current Home to School Transport Policy states that free transport will be provided for Primary School pupils who reside over 2 miles from their nearest appropriate school.

There are currently 14 pupils receiving Home to School Transport to either Ysgol Llanddoged or Ysbyty Ifan that live over 2 miles from both schools.

Should the Proposal to federate the schools be approved, there will be no changes to the current transport provision. Pupils will continue to receive their education from the same site as they currently do and therefore will not be eligible for free Home to School Transport.

10. Admissions

Conwy Education Service will remain as the admissions authority both during and after the federation of both schools.

Teaching groups will remain within the statutory limit of 30 pupils in the foundation phase classes and 30 or less for key stage 2 classes pupils.

11. Consultation Process

This document marks the initiation of the consultation process.

This period of consultation will last until the <u>25th November 2024.</u> As a result of the consultation the Council may decide not to proceed any further with the proposal or to go ahead with the proposal or a modified version of it.

A copy of this proposal will be published on Conwy County Borough Council's website.

The Local Authority will inform the current governing bodies of their decision and publish the outcome on their website whilst informing staff, parents/guardians, and unions directly.

12. Equality Impact Assessment

The information for the schools demonstrates a diverse school population and there is no indication that any learners would be disadvantaged should the proposal go ahead; given that they will both remain on the same site and learners will have little change in their daily school routine.
