**Conwy County Borough Council (Footpaths 13, 14 and 15 Llanfihangel Glyn Myfyr) (Temporary Prohibition of Pedestrians) Order 2018**

**NOTICE IS GIVEN** that the Conwy County Borough Council intend not less than seven days from the date hereof to make an Order, the effect of which is to prohibit any pedestrian to proceed in those sections of footpaths in the community of Llanfihangel Glyn Myfyr as specified in the Schedule below.

Footpaths in the Community of Llanfihangel Glyn Myfyr

Footpath 13 commencing from forest track and footpath 10 at grid reference SJ 0058 5143 proceeding north east to Conwy County Borough Boundary at grid reference SJ 0130 5223.

Footpath 14 commencing from forest track and footpath 10 at grid reference SJ 0170 5112 proceeding north westerly to Conwy County Borough Boundary at grid reference SJ 0144 5210.

Footpath 15 commencing from forest track and Conwy County Borough Boundary at grid reference SJ 0178 5078 proceeding north westerly to footpath 10 at SJ 0138 5117.

The Order is necessary for the reason of likelihood of danger to the public.

The Order will come into effect on 26 February 2018. It is anticipated that the footpaths will be closed until the works which it is proposed to carry out have been completed, subject to a maximum period of 6 months.
