Yn unol ag Adran 89 Deddf Fframwaith a Safonau Ysgolion 1998, rwy'n ysgrifennu i ymgynghori â chi am drefniadau derbyn arfaethedig Cyngor Bwrdeistref Sirol Conwy ar gyfer 2020/2021. Rhaid i'r ymgynghori ddod i ben erbyn 1 Mawrth 2019 a rhaid i'r trefniadau gael eu pennu erbyn 15 Ebrill 2019. Yr ymgynghoreion Statudol yw cyrff llywodraethu pob ysgol, yr awdurdodau esgobaethol ac awdurdodau lleol cyfagos. Rhaid i'r ymgynghoriad gynnwys yr holl drefniadau derbyn gan gynnwys pa niferoedd i'w derbyn.

Mae'r trefniadau derbyn arfaethedig i'w gweld yn y ddogfen sydd ynghlwm. Mae niferoedd derbyn i ysgolion hefyd wedi'u hatodi. Nid oes newidiadau wedi'u cynnig i'r polisiau ar gyfer derbyniadau ysgolion o fis Medi 2020 ymlaen.

Gellir diwygio'r niferoedd derbyn (h.y. nifer y disgyblion y gellir eu derbyn i un grŵp blwyddyn) i adlewyrchu newid mewn adeiladau yn unig. Bydd unrhyw newidiadau a gytunir ar ôl yr ymgynghoriad hwn yn weithredol o fis Medi 2020 ar y cynharaf. **Gan ystyried hyn, os hoffech i'r nifer derbyn ar gyfer eich ysgol adlewyrchu newid yn yr adeiladau, cysylltwch â mi cyn gynted ag y bo modd.**

**SCHOOL ADMISSION ARRANGEMENTS  
2020/2021  
ANNUAL CONSULTATION ON ADMISSION  
ARRANGEMENTS, INCLUDING ADMISSION  
NUMBERS.**

In accordance with Section 89 of the School Standards and Framework Act 1998, I am writing to consult with you about Conwy County Borough Council's proposed admission arrangements for 2020/2021. The consultation must be concluded by 1<sup>st</sup> March 2019 and the arrangements must be determined by 15<sup>th</sup> April 2019. Statutory consultees are the governing bodies of all schools, the diocesan authorities and neighbouring local authorities. Consultation must cover all admission arrangements, including admission numbers.

The proposed admission arrangements are set out in the attached document. School admission numbers are also attached. No amendments are proposed to the policies for school admissions from September 2020.

Admission numbers (i.e. the number of pupils that can be admitted to a year group) can only be amended to reflect a change in accommodation. Any changes agreed following this consultation will be effective from September 2020 at the earliest. **Taking this into account, if you would like the admission number for your school to reflect a change in accommodation, please contact me as soon as possible.**

A common timetable for admissions for 2020/21 has been provisionally agreed with our neighbouring authorities.

If you have any comments in relation to the proposed admission arrangements for 2020/2021 please let me have them no later than **Friday 1<sup>st</sup> March 2019**.
