The County Borough of Conwy (Footpath 13 in the Community of Betws yn Rhos)
Public Path Diversion Order 2020

The above Order made on 18 August 2020, under Section 257 of the Town and Country Planning Act 1990, will divert that section of public footpath No 13 in the Community of Betws yn Rhos in the County Borough of Conwy commencing from the B5383 (Dolwen Road) to the north west of Dolgau running parallel with the Colwyn Bay Town Council Boundary and to the south of Ffordd Las for approximately 160 metres before turning south west to the Colwyn Bay Town Council Boundary and its junction with Footpath 43, Colwyn Bay.

Any representations or objections to the Order can be sent in writing to Environment Roads and Facilities, PO Box 1 Conwy LL30 9GN or erf@conwy.gov.uk not later than 25 September 2020.

If the Order is sent to the Secretary of State for Wales for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
