**The County Borough of Conwy
(Trafford Park and Llandudno Road, Penrhyn Bay)
(Prohibition and Restriction of Waiting) Order 2021**

On 21 January 2021 the Conwy County Borough Council made the above-named Order under Sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which is to

1. Prohibit the waiting of vehicles at any time in the length of road specified in Schedule 1.
2. Limit waiting to 40 minutes, 8am to 6pm, no return within 120 minutes in the length of road specified in Schedule 2
3. Limit waiting to 120 minutes, 8am to 6pm, no return within 120 minutes in the lengths of road specified in Schedule 3
4. Revoke the restrictions specified in Schedule 4.

Exceptions are provided in the Order to permit waiting for the purposes of alighting, boarding, loading, unloading and works of maintenance, repair and the like and Vehicles displaying both a disabled person's badge and a disabled person's parking disc

A copy of the Order and plans, which will come into operation on 1 February 2021 may be viewed on the Council website.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date hereof apply to the High Court for this purpose.

Schedule 1

No waiting at any time

Trafford Park	Eastern side – from a point 46 metres north of its junction with Plas Penrhyn for a distance of 6 metres in a northerly direction.

Schedule 2

Limited waiting 40 minutes, 8am to 6pm, no return within 120 minutes

Trafford Park	Southern side; From a point 11 metres east of its junction with Sunningdale Drive for a distance of 2.6 metres in an easterly direction.

Schedule 3

Limited waiting 120 minutes, 8am to 6pm, no return within 120 minutes.

Llandudno Road	North-eastern side, from a point 45 metres north-west of its junction with Marine road for a distance of 14 metres in a north-westerly direction.
Trafford Park	Western side; from a point 25 metres north of its junction with Plas Penrhyn for a distance of 17 metres in a northerly direction.

Schedule 4
Revocation

Trafford Park	Eastern side – from a point 46 metres north of its junction with Plas Penrhyn for a distance of 6 metres in a northerly direction. Western side – from a point 25metres north of its junction with Plas Penrhyn for a distance of 22 metres in a northerly direction.
