**GORCHYMYN (CYDGRYNHOI) BWRDEISTREF SIROL CONWY (ATAL A CHYFYNGU AROS A  
MANNAU PARCIO ODDI AR Y STRYD) 2006 GORCHYMYN (DIWYGIAD RHIF 2) 2017 –

Yn unol â'i bwerau dan Adrannau 1(1), 2(1) i (3) a Rhan IV Atodlen 9, Deddf Rheoli Trafnidiaeth Ffyrdd 1984 (y cyfeirir ati o hyn ymlaen fel "Deddf 1984"), a'r holl bwerau galluogi eraill, ac ar ôl ymgynghori gyda Phrif Swyddog yr Heddlu yn unol â Rhan III Atodlen 9 Deddf 1984, y mae Cyngor Bwrdeistref Sirol Conwy (y cyfeirir ato o hyn ymlaen fel "y Cyngor") yn gwneud drwy hyn y Gorchymyn a ganlyn:

1. Bydd y Gorchymyn hwn yn dod i rym ar y <sup>1<sup>af</sup></sup> dydd o *Aws* dwy fil a deunaw, a gellir cyfeirio ato fel "Gorchymyn (Cydgrynhai) Bwrdeistref Sirol Conwy 2006 (Atal a Chyfyngu Aros a Mannau Parcio Oddi ar y Stryd) Gorchymyn (Diwygiad Rhif 2) 2017 – Promenâd Bae Colwyn".

2. (1) Yn y Gorchymyn hwn:

(a) Caiff Gorchymyn (Cydgrynhai) Bwrdeistref Sirol Conwy (Atal a Chyfyngu Aros a Mannau Parcio Oddi ar y Stryd) 2006 ei ddiwygio drwy hyn i'r graddau fod Atodlenni 2, 4 a 6 yn cael eu diwygio i gynnwys y darnau o ffordd fel y manylir yn yr Atodlenni isod.

Mae "Tystysgrif Esgusodi Masnachwyr" yn golygu tystysgrif a roddwyd ar ran y Cyngor i bwrrpas Erthygl 25, sy'n caniatáu Cerbyd penodol i aros dan amgylchiadau penodol ar ddarn neu ddarnau o ffordd lle byddai'r cerbyd hwnnw wedi'i atal rhag aros fel arall

Mae "Carafán Fodur" yn golygu unrhyw garafán fodur, carafanet, cerbydau gwerysilla neu unrhyw gerbyd a yrrir gan fodur sydd wedi cael ei wneud neu wedi ei drawsnewid i fod yn gerbyd campio neu i gysgu ynddo.

Mae "Ceir a Faniau Ysgafn" yn golygu Car Modur fel y'i diffiniwyd yn Rheoliadau Cerbydau Ffordd (Gwneuthuriad a Defnydd) 1986; neu'r un ystyr â char modur yn Adran 185 Deddf Trafnidiaeth Ffordd 1988.

3. Bydd y gwaharddiadau a'r cyfyngiadau sy'n cael eu gosod gan y Gorchymyn hwn yn ychwanegol at unrhyw gyfyngiad neu amod sy'n cael ei osod gan unrhyw reoliadau sydd wedi eu gwneud dan Ddeddf 1984, neu sydd mewn grym fel pe baent wedi eu gwneud naill ai dan y Ddeddf honno neu dan unrhyw ddeddf arall, ac ni fyddant yn tynnu oddi wrtho.

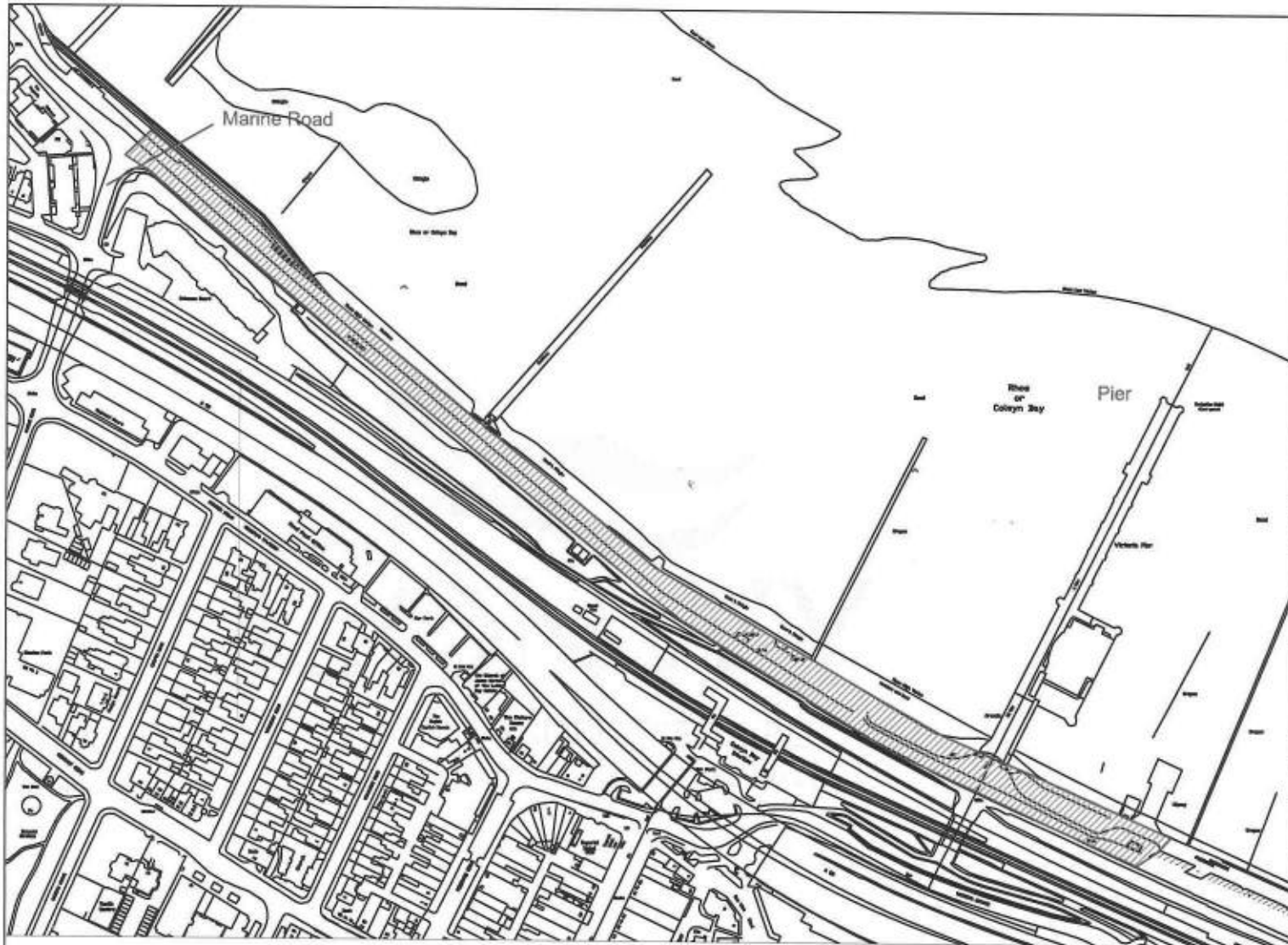

**The County Borough Of Conwy**  
**(Prohibition And Restriction Of Waiting & On Street Parking Places)**  
**(Consolidation) Order 2006 (Amendment No 2) Order 2017 – Colwyn Bay Promenade**

The Conwy County Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

1. This Order shall come into operation on the 1<sup>st</sup> day of August Two thousand and eighteen and may be cited as "The County Borough of Conwy (Prohibition and Restriction of Waiting & On Street Parking Places) (Consolidation) Order 2006 (Amendment No 2) Order 2017 – Colwyn Bay Promenade".

2. (1) In this Order:-

(a) The County Borough of Conwy (Prohibition and Restriction of Waiting & On Street Parking Places) (Consolidation) Order 2006 is hereby amended insofar as Schedules 2, 4 and 6 are amended to include the lengths of road as specified in the Schedules below.

"Commercial dispensation certificate" means a certificate duly issued on behalf of the Council for the purposes of Article 25 permitting a specified Vehicle to wait in specified circumstances on a length or lengths of road where the waiting of that Vehicle would otherwise be restricted

"Motor Caravan" means any motorised caravan caravanette campervan or any other mechanically propelled vehicle which has been made or converted as a camping vehicle or to sleep in.

"Cars and Light Vans" means Motor Car as defined in Road Vehicles (Construction and Use) Regulations 1986; or has the same meaning as motor car in Section 185 of the Road Traffic Act 1988.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
