(Llangernyw, Llanfairtalhaiarn and B5381 Moelfre - 40mph Speed Limit) Order
2026

The Conwy County Borough Council proposes to make an Order under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 the effect of which will prohibit any person from driving any motor vehicle at a speed exceeding 40 miles per hour in the lengths of road specified in the Schedule below.

A copy of the proposed Order together with a map showing the lengths of road to which the Order relates and a statement of the Council's reasons for proposing to make the Order may be examined at the Council Offices Coed Pella, Colwyn Bay, Abergele Library and on the Council website. Objections to the proposed Order, together with the grounds on which they are made should be sent in writing to the Traffic Section, Environment Roads and Facilities, PO Box 1 Colwyn Bay LL29 0GG or to tro@conwy.gov.uk by 20 February 2026.

40mph Speed Limit

Turnpike Ucha to Nant Mawr	From a point 65 metres north of its junction with Cae Llan, Llangernyw to a point 45 metres east of the turning to Nant Mawr, a distance of approximately 4 kilometres
Llanfair Road	From a point 165 metres north of its junction with Llanfairtalhaiarn Road to Waen Fawr Isaf, Llanfairtalhaiarn to a point 100 metres east of the turning to Court Haw, a distance of approximately 600 metres
B5381 – County Boundary to A548	From a point 60 metres east of its junction with Fadre Road to a point 195 metres west of the access to Lakeside Lodges, a distance of approximately 1.1km
