(B5106 Conway Road, Dolgarrog - 20mph Speed Limit) Order 2019

The Conwy County Borough Council proposes to make an Order under Sections 84(1) and (2) of the Road Traffic Regulation Act 1984 the effect of which will prohibit any person from driving any motor vehicle at a speed exceeding 20 miles per hour in the length of road specified in the Schedule below.

A copy of the proposed Order, together with a map showing the road to which the Order relates and a statement of the Council's reasons for making the Order may be examined at the offices of the Head of Law and Governance, Bodlondeb, Conwy, at Llanrwst Library during normal opening/office hours and on the Council's website.
