### **Gorchymyn Bwrdeistref Sirol Conwy (Gwhardd Stopio) (Safleoedd Cerbydau Hacni) a Chyfyngu ar Aros [Amendment Order 2025](#)**

#### **Cyflwyniad:**

Mae Cyngor Bwrdeistref Sirol Conwy, yn dilyn adolygiad, yn cynnig sefydlu neu ddileu standiau cerbydau hacni yn y lleoliadau a nodir yn yr Atodlenni yn yr Hysbysiad ar gyfer y Gorchymyn hwn, er mwyn gwella gwasanaethau trafnidiaeth a sicrhau diogelwch a chyfleustra i deithwyr.

## **STATEMENT OF REASONS**

### **The County Borough of Conwy (Prohibition of Stopping) (Hackney Carriage Stands) & Limited Waiting Amendment Order 2025.**

#### **Introduction:**

Conwy County Borough Council, following review proposes to establish or extinguish hackney carriage stands at the locations set out in the Schedules in the Notice for this Order, to improve transportation services and ensure the safety and convenience of passengers.

**Background:** Hackney carriages play a vital role in providing accessible and reliable transportation. The current locations of designated stands have been reviewed to minimise issues such as congestion, unsafe boarding practices, and inconvenience for passengers.

#### **Objectives:**

1. **Safety:** To enhance the safety of passengers by providing a designated area for boarding and alighting.
2. **Accessibility:** To ensure that hackney carriages are easily accessible to all members of the community, including those with disabilities.
3. **Efficiency:** To reduce traffic congestion and improve the flow of vehicles in the area.
