Notice is hereby given that an application has been made by *Mr R E Williams* to *Conwy County Borough Council* of as Commons Registration Authority, concerning land at *Llys y Gwynt, Llanfairfechan* described more fully below.

A summary of the effect of the application is as follows: the parcel of land was included as Common Land on the Common Land plans under CL7, the unenclosed mountain land in the Parish of Llanfairfechan.

If the application is granted, in whole or in part, the registration authority will give effect to the determination by *removing* the land *from* the plan of *common land*.

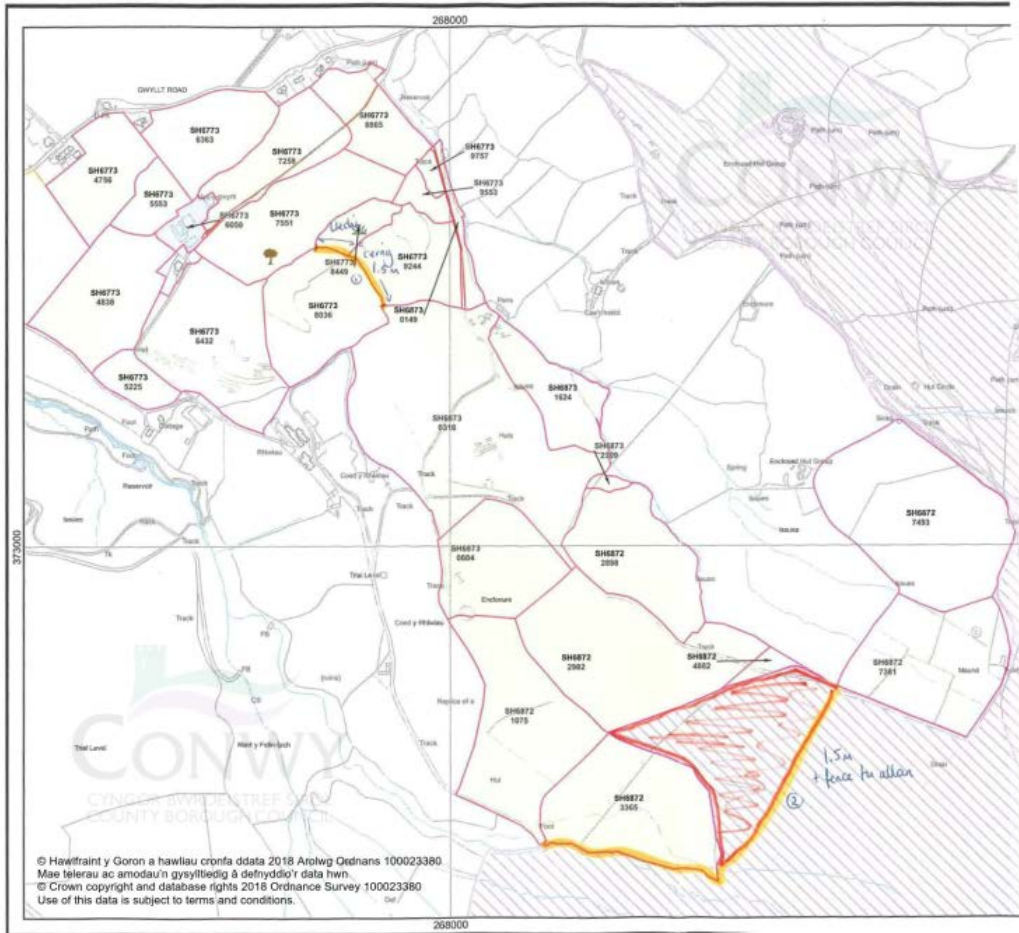
