





Environmental Protection Act 1990 Part IIA Contaminated Land

The requirement for this Public Register to be maintained was brought into effect by Section 15 of The Contaminated Land (Wales) Regulations 2001 which were made on 12th June 2001 and came into force on 1st July 2001 under Statutory Instrument 2001 No.2197 (W.157).

The Public Register is maintained by the Regulatory Services Department and may be viewed at Coed Pella, Conway Road, Colwyn Bay, LL29 7AZ between the hours of 09.00 and 17.00 Monday to Thursday and 09.00 and 16.45 Friday.
