	It is situated next to and within Bodafon Farm Park, which holds domestic animals and does not require a zoo licence. The Owls Trust's facilities for birds and ancillary rooms are clearly distinct from the Farm Park so that the zoo-licenced premises are clear.
	The Owls Trust operates with a 14(2) dispensation under the Zoo Licensing Act 1981 by virtue of the small number and kinds of wild species held. This inspection confirms the opinion that this dispensation is still appropriate.

The Owl Trust operators, staff and volunteers are thanked for their courteous and helpful approach to the inspection, and for the pre-inspection audit and supporting paperwork.

The management, staff and volunteers are knowledgeable and enthusuastic and the overall ambience of the Zoo is of an attractive, well-run establishment.

The creation of the wildlife garden is an excellent new initiative and has great potential to expand the Owl Trust's environmental education potential.

The following Recommendations are made:

- 1. All cupboards, fridges and freezers in the animal food room should be clealry labelled 'for animal food only' to ensure staff and volunteers do not use them for human food items.
- 2. It is good practice for all bird aviaries to have double-door security staff access. It is not practical to provide these retrospectively to existing aviaries because of the layout and path proximity. However, all new aviairies should have such double security doors fitted as standard.
- 3. It is a good idea to advise all staff and volunteers who work with the birds to inform their GP that they work with animals.
- 4. There is an existing programme of veterinary care agreed with a local practice. However, this should be available to the zoo licensing inspection process as a written outline, including all main elements, as agreed and signed off by the vet.
- 5. The vet's CPD record should be available to the zoo licensing process.
- 6. There was extensive paperwork presented regarding the in situ conservation work being carried out in the Dominican Republic. However, some of this was a little dated and it is recommended that updates on progress should be sent from DR to the Owls Trust (emails will be fine) at least annually so these can be scrutinised by the licensing process.
- 7. When birds are taken out of their aviaries for handling by staff and volunteers, records are currently maintained. However, these do not distinguish between on-site and off-site activity. Given the additional boxing and travelling for outreach work it is recommended that separate records should be kept of these two kinds of handling activity.
- 8. An ethical review process has been established and is functioning. However, it does not include an outside person. Such a person, with no financial or practical involvement with the Owls Trust, should be part of the process.
- 9. It is acknowledged that as a free admission attraction the Owls Trust can only estimate annual visitor numbers. However, records of education talks, both on and off site, should be possible and to a reasonably accurate level. Such records could be made available to the zoo licensing process and would help to quantify impact.
