**RHAN 1**

**CYFFREDINOL**

**1. Dehongliad o Ran 1**

Yn yr Is-ddeddfau hyn:

“y Cyngor” yw Cyngor Bwrdeistref Sirol Conwy;

“tiroedd” yw unrhyw un o'r tiroedd sy'n cael eu rhestru yn Atodlen 1;

“mannau dynodedig” yw ardal o dir a neilltuwyd i bwrpas penodol a bod yr ardal honno a'i phwrpas yn cael ei dangos gan arwyddion mewn safleoedd amlwg;

“Cerbyd pobl anabl” yw cerbyd, gyda gyriant mecanyddol neu hebddo, gyda'i bwysau heb fod yn drymach na 150 cilogram heb ei lwytho, ac nid yw'n lletach na 0.85 metr, ac sydd wedi cael ei addasu at gludo unigolyn gydag anabledd ac sy'n cael ei ddefnyddio gan yr unigolyn hwnnw/honno'n unig.

**Gweithredu**

2. Mae'r is-ddeddfau hyn yn weithredol yn yr holl feysydd a restrir yn Atodlen 1 oni bai y nodir yn wahanol.

**Oriau Agor**

3. (1) Dim ond yn ystod oriau agor caiff unrhyw un fynediad i neu aros ar y tiroedd.

(2) Mae “oriau agor” yn golygu'r diwrnodau a'r amseroedd lle mae'r tir ar agor i'r cyhoedd, sy'n cael ei nodi pan fo unrhyw giât ar agor a heb ei chloi.

**Byelaws  
Pleasure Grounds, Public Walks and  
Open Spaces**

made under section 164 of the Public Health Act 1875 and section 15 of the Open Spaces Act 1906 by the Council of Conwy County Borough with respect to pleasure grounds, public walks and open spaces specified in the Schedules hereto.

**PART 1**

**GENERAL**

**1. Interpretation of Part 1**

In these byelaws:

“the Council” means the Council of the County Borough of Conwy;

“the ground” means any of the grounds listed in Schedule 1;

“designated area” means an area in the ground which is set aside for a specified purpose, that area and its purpose to be indicated by notices placed in a conspicuous position;

“invalid carriage” means a vehicle, whether mechanically propelled or not, the unladen weight of which does not exceed 150 kilograms, the width of which does not exceed 0.85 metres, and which has been adapted for use for the carriage of a person suffering from a disability, and used solely by such a person.

**Application**

2. These byelaws apply to all of the grounds listed in Schedule 1 unless otherwise stated.

**Opening times**

3. (1) No person shall enter or remain in the ground except during opening hours.

(2) “Opening hours” means the days and times during which the ground is open to the public indicated when any gates are open or unlocked.

### **Diogelu adeileddau a phlanhigion**

4. (1) Ni chaiff unrhyw un heb reswm da symud na mynd â'r eitemau a ganlyn o'r tiroedd:

(a) unrhyw atalfa, postyn, sedd neu offer, nac unrhyw ran o adeiledd neu addurn sy'n cael ei ddarparu i osod neu i gynnal y tiroedd; nac

(b) unrhyw garreg, pridd na glaswellt neu blanhigyn, llwyn na choeden, na rhannau ohonynt.

(2) Ni chaiff unrhyw un dywys na marchogaeth na gyrru, cerdded na sefyll ceffyl nac unrhyw gerbyd arall dros:

(a) unrhyw wely blodau, llwyn na phlanhigyn;

(b) unrhyw dir sy'n cael ei baratoi fel gwely blodau neu i dyfu unrhyw goeden, llwyn neu blanhigyn; neu

(c) unrhyw ran o'r tir sydd wedi ei neilltuo gan y Cyngor i adnewyddu glaswellt neu ar gyfer ei dirwedd fel arall, ac sy'n cael ei ddangos gan arwydd mewn man amlwg.

### **Adeiladu adeileddau heb ganiatâd**

5. Ni chaiff unrhyw un godi unrhyw atalfa, postyn, reid na siglen, adeilad nac unrhyw adeiledd arall heb ganiatâd ysgrifenedig y Cyngor.

### **Pori**

6. Ni chaiff unrhyw un droi allan unrhyw anifail y mae'n gyfrifol amdano na chaniatáu iddo bori ar y tir, heb ganiatâd ysgrifenedig y Cyngor.

### **Diogelu bywyd gwyllt**

7. Ni chaiff unrhyw un ladd, anafu, cymryd unrhyw anifail neu aflonyddu arno, na hela, na saethu, na gosod trapiau na rhwydi na gosod maglau, heb ganiatâd ysgrifenedig y Cyngor.

## **PART 2**

## **PROTECTION OF THE GROUND, ITS WILDLIFE AND THE PUBLIC**

### **Protection of structures and plants**

4. (1) No person shall without reasonable excuse remove from or displace within the ground:

(a) any barrier, post, seat, or implement, or any part of a structure or ornament provided for use in the laying out or maintenance of the ground; or

(b) any stone, soil or turf or the whole or any part of any plant, shrub or tree.

(2) No person shall walk on or ride, drive or station a horse or any vehicle over:

(a) any flower bed, shrub or plant;

(b) any ground in the course of preparation as a flower bed or for the growth of any tree, shrub or plant; or

(c) any part of the ground set aside by the Council for the renovation of turf or for other landscaping purposes and indicated by a notice conspicuously displayed.

### **Unauthorised erection of structures**

5. No person shall without the written consent of the Council erect any barrier, post, ride or swing, building or any other structure.

### **Grazing**

6. No person shall without the written consent of the Council turn out or permit any animal for which he is responsible to graze in the ground.

### **Protection of wildlife**

7. No person shall kill, injure, take or disturb any animal, or engage in hunting or shooting, or the setting of traps or nets

## **Giatiau**

8. (1) Ni chaiff unrhyw un adael unrhyw giât, y mae'r is-ddeddf hon yn berthnasol iddi, ar agor ac a agorwyd neu a achoswyd iddi gael ei hagor ganddo/ganddi.
- (2) Mae Is-ddeddf 8 yn berthnasol i unrhyw giât ag arwydd amlwg arni neu gerllaw iddi sy'n gwahardd gadael y giât ar agor.

## **Gwersylla**

9. Ni chaiff unrhyw un godi pabell na defnyddio cerbyd, carafân nac unrhyw isadeiledd arall i wersylla ynddynt, ac eithrio mewn man a ddynodwyd ar gyfer hynny, heb ganiatâd ysgrifenedig y Cyngor.

## **Tanau**

10. (1) Ni chaiff unrhyw gynnu tan na gosod, taflu neu ddisgyn matsien wedi'u goleuo nac unrhyw beth arall allai gynnu tan.
- (2) Ni fydd Is-ddeddf 10(1) yn berthnasol i:
- (a) cynnu tan mewn unrhyw ddigwyddiad a gafodd ganiatâd gan y Cyngor i gynnu tan ynddo; neu
- (b) cynnu neu ddefnyddio stôf wersylla, sydd wedi ei rhoi at ei gilydd yn briodol, mewn man penodol ar gyfer gwersylla, neu farbiciw sydd wedi ei roi at ei gilydd yn briodol mewn man penodol i farbiciws, mewn modd i ddiogelu rhag unrhyw ddifrod i'r tir ac unrhyw berygl i bobl.

## **Taflegrau**

11. Ni chaiff unrhyw un daflu na defnyddio unrhyw ddyfais i yrru neu ollwng unrhyw beth ar y tir a fyddai'n anafu unrhyw un.

## **Amharu ar offer achub bywyd**

or the laying of snares without the written consent of the Council.

## **Gates**

8. (1) No person shall leave open any gate to which this byelaw applies and which he has opened or caused to be opened.
- (2) Byelaw 8(1) applies to any gate to which is attached, or near to which is displayed, a conspicuous notice stating that leaving the gate open is prohibited.

## **Camping**

9. No person shall without the written consent of the Council erect a tent or use a vehicle, caravan or any other structure for the purpose of camping except in a designated area for camping.

## **Fires**

10. (1) No person shall light a fire or place, throw or drop a lighted match or any other thing likely to cause a fire.
- (2) Byelaw 10(1) shall not apply to:
- (a) the lighting of a fire at any event for which the Council has given permission that fires may be lit; or
- (b) the lighting or use, in such a manner as to safeguard against damage or danger to any person, of a properly constructed camping stove, in a designated area for camping, or of a properly constructed barbecue, in a designated area for barbecues.

## **Missiles**

11. No person shall throw or use any device to propel or discharge in the ground any object which is liable to cause injury to any other person.

## **Interference with life-saving**

12. Ni chaiff unrhyw un, heblaw mewn argyfwng, dynnu, symud neu ymyrryd ag unrhyw offer achub bywyd, sydd ar y tir ac sy'n cael ei ddarparu gan y Cyngor.

### Dringo

13. Ni ddylai unrhyw unigolyn ddringo unrhyw wal neu ffens ar y tir nac o'i amgylch, nac unrhyw rwystr, rheilin, postyn neu strwythur arall, heb reswm da.

### Rhan 3

#### Ceffylau, Beiciau a Cherbydau

Dehongli Rhan 3

Yn y Rhan hon:

mae "llwybr dynodedig" yn golygu llwybr mewn tiroedd neu drwyddynt sydd wedi ei neilltuo i bwrpas penodol, a bod y llwybr a'i bwrpas wedi ei nodi gan arwyddion mewn mannau amlwg;

mae "beic modur" yn golygu cerbyd a gyriant mecanyddol, nad yw'n cerbyd pobl anabl, gyda llai na phedair olwyn ac heb fod yn drymach na 410 cilogram;

mae "cerbyd modur" yn golygu cerbyd a gyriant mecanyddol ac eithrio beic modur a cherbyd pobl anabl;

mae "trelar" yn golygu cerbyd a dynnir gan gerbyd modur, ac mae'n cynnwys carafan.

#### Ceffylau

14(1) Ni chaiff unrhyw un farchogaeth ceffyl ar y tir ac eithrio:

- (a) ar lwybr penodol ar gyfer marchogaeth; neu
  - (b) wrth arfer hawl cyfreithiol neu fraint.
- (2) Lle caniateir marchogaeth dan is-ddeddf 14(1)(a) neu wrth arfer hawl cyfreithiol neu fraint, ni chaiff unrhyw un farchogaeth ceffyl mewn modd a fyddai'n peryglu unrhyw un arall.

### equipment

12. No person shall except in case of emergency remove from or displace within the ground or otherwise tamper with any life-saving appliance provided by the Council.

### Climbing

13. No person shall without reasonable excuse climb any wall or fence in or enclosing the ground, or any barrier, railing, post or other structure.

### Part 3

#### Horses, Cycles & Vehicles

Interpretation of Part 3

In this Part:

"designated route" means a route in or through a ground which is set aside for a specified purpose, its route and that purpose to be indicated by notices placed in a conspicuous position;

"motor cycle" means a mechanically propelled vehicle, not being an invalid carriage, with less than four wheels and the weight of which does not exceed 410 kilograms;

"motor vehicle" means a mechanically propelled vehicle other than a motor cycle or invalid carriage;

"trailer" means a vehicle drawn by a motor vehicle, and includes a caravan.

#### Horses

14 (1) No person shall ride a horse in the ground except:

- (a) on a designated route for riding; or
- (b) in the exercise of a lawful right or privilege.

(2) Where horse riding is permitted by virtue of byelaw 14(1)(a) or a lawful right or privilege, no person shall ride a horse in such a manner as to cause danger to any other person.

## **Beicio**

15. Ni chaiff unrhyw un fynd ar hyd y tir ar gefn beic, heb reswm da, mewn modd a fyddai'n beryglus neu a fyddai'n creu annifyrrwch i bobl eraill.

## **Cerbydau Modur**

16. (1) Ni chaiff unrhyw un, heb reswm da, ddod â beic modur, yrru cerbyd modur na threlar ar y tir, heb reswm da, ac eithrio lle ceir hawl tramwy ar gyfer y dosbarth cerbyd hwnnw neu ar lwybr dynodedig i gerbydau modur.

(2) Lle ceir llwybr dynodedig ar y tir ar gyfer cerbydau modur, ni fydd yn drosedd dan is-ddeddf 16(1) i ddod â cherbyd modur i'r tir, neu ei yrru yno, er mwyn mynd ag ef i'r llwybr dynodedig yn unig.

## **Parcio Dros Nos**

17. Ni chaiff unrhyw un adael neu achosi i feic modur, cerbyd modur na threlar gael eu gadael ar y tir rhwng yr oriau o 10pm a 6am, heb ganiatâd ysgrifenedig y Cyngor

## **RHAN 4**

### **Llecynnau Chwarae, Gemau a Chwaraeon**

#### **Dehongli Rhan 4**

Yn y Rhan hon:

"Gemau pêl" yw unrhyw gêm sy'n cynnwys taflu, dal, cicio, batio neu redeg gyda phêl neu wrthych arall a gafodd ei gynllunio i'w daflu a'i ddal, ond nid yw'n cynnwys criced;

"cwrs golff" yw unrhyw ardal ar y tir a gafodd ei neilltuo ar gyfer chwarae golff ac mae'n cynnwys unrhyw faes ymarfer golff neu pytio;

mae "cerbyd hunanyredig" yn gerbyd heblaw am feiciau, cerbyd pobl anabl neu bram sy'n cael ei yrru gan bwysau neu rym un neu ragor o bobl yn sglefrio, llithro neu yn y cerbyd, neu gyda un neu

## **Cycling**

15. No person shall without reasonable excuse ride a cycle in such a manner as to cause danger or give reasonable grounds for annoyance to other persons.

## **Motor vehicles**

16. (1) No person shall without reasonable excuse bring into or drive in the ground a motor vehicle or trailer except in any part of the ground where there is a right of way for that class of vehicle or on a designated route for motor vehicles.

(2) Where there is a designated route in the ground for motor vehicles, it shall not be an offence under byelaw 16(1) to bring into or drive a motor vehicle in the ground for the sole purpose of transporting it to the designated route.

## **Overnight parking**

17. No person shall without the written consent of the Council leave or cause or permit to be left any motor cycle, motor vehicle or trailer in the ground between the hours of 10pm and 6am.

## **PART 4**

### **Play Areas, Games & Sports**

#### **Interpretation of Part 4**

In this Part:

"ball games" means any game involving throwing, catching, kicking, batting or running with any ball or other object designed for throwing and catching, but does not include cricket;

"golf course" means any area within the ground set aside for the purposes of playing golf and includes any golf driving range, golf practice area or putting course;

"self-propelled vehicle" means a vehicle other than a cycle, invalid carriage or pram which is propelled by the weight or force of one or more persons skating,

### **Llecynnau chwarae plant**

18. Ni chaiff unrhyw un 14 oed neu'n hŷn fynd i lecyn sydd wedi ei ddynodi'n llecyn chwarae plant, nac aros yno, oni bai eu bod yn gyfrifol am blentyn dan 14 oed.

### **Children's play areas**

18. No person aged 14 years or over shall enter or remain in a designated area which is a children's play area unless bona fide in charge of a child under the age of 14 years.

### **Cyfarpar Chwarae Plant**

19. Ni chaiff unrhyw un 14 oed neu'n hŷn ddefnyddio unrhyw gyfarpar a nodwyd ei fod ar gyfer unigolion dan 14 oed yn unig, gan rybudd amlwg ar y cyfarpar neu gerllaw iddo.

### **Children's play apparatus**

19. No person aged 14 years or over shall use any apparatus stated to be for the exclusive use of persons under the age of 14 years by a notice conspicuously displayed on or near the apparatus.

### **Sglefrfyrrddio, ac yn y blaen.**

20. Ni chaiff unrhyw un sglefrio, llithro na sglefrolio / llafnrolio ar sglefrfyrrddau nac unrhyw gerbydau eraill hunanyredig mewn modd a fyddai'n beryglus neu a fyddai'n rhoi achos digonol i greu annifyrrwch i bobl eraill.

### **Skateboarding Etc.**

20. No person shall skate, slide or ride on rollers, skateboards or other self-propelled vehicles in such a manner as to cause danger or give reasonable grounds for annoyance to other persons.

### **Gemau Pêl**

21(1). Ni chaiff unrhyw un chwarae gemau pêl ar unrhyw dir ag arwydd mewn man amlwg yn gwahardd gemau pêl.

(2) Ni chaiff unrhyw un chwarae gemau pêl ar unrhyw faes yn y fath fodd:

(a) sy'n eithrio pobl nad ydynt yn chwarae gemau pêl rhag defnyddio'r rhan honno o'r tir;

(b) sy'n peryglu neu roi achos digonol i greu annifyrrwch i bobl eraill ar y maes; neu

(c) sy'n debygol o ddifrodi unrhyw goeden, llwyn neu blanhigyn ar y tir.

### **Ball games**

21 (1) No person shall play ball games in any ground which displays in a conspicuous position a sign prohibiting ball games.

(2) No person shall play ball games in any ground in such a manner:

(a) as to exclude persons not playing ball games from use of that part;

(b) as to cause danger or give reasonable grounds for annoyance to any other person in the ground; or

(c) which is likely to cause damage to any tree, shrub or plant in the ground.

### **Criced**

22. Ni chaiff unrhyw un daflu pêl griced na'i tharo â bat, ac eithrio mewn llecyn a neilltuwyd ar gyfer chwarae criced

### **Cricket**

22. No person shall throw or strike with a bat a cricket ball except in a designated area for playing cricket.

### **Saethyddiaeth**

23. Ni chaiff unrhyw un arfer saethyddiaeth ac eithrio mewn digwyddiad a drefnir neu a gynhelir gyda chaniatâd ysgrifenedig y Cyngor.

### **Mabolgampau Maes**

24. Ni chaiff unrhyw un daflu gwaywffon, morthwyl, disgen na phwysau, ac eithrio mewn digwyddiad a drefnir gan y Cyngor neu gyda chaniatâd ysgrifenedig y Cyngor, neu ar dir a neilltuwyd gan y Cyngor i'r pwrpas hwnnw.

### **Golff**

25. Ni chaiff unrhyw un yrru, tsipio na phitsio pêl golff galed ac eithrio mewn llecyn a gafodd ei neilltuo'n benodol drwy rybudd gan y Cyngor i fod yn gwrs golff, maes ymarfer golff neu gwrs pytio.

## **RHAN 5**

### **Dyfrffyrdd**

Dehongli Rhan 5

Yn y rhan hon:

"cwch" yw unrhyw gwch hwylio, cwch modur neu gwch tebyg ond nid cwch tegan na chwch model;

ystyr "wedi'i bweru" yw wedi'i yrru gan losgi anwedd petrol neu sylweddau llosgadwy eraill;

"dyfrffordd" yw unrhyw afon, llyn, pwll neu unrhyw ardal arall o ddŵr, gan gynnwys ffowntenni.

### **Ymdrochi**

26. Ni chaiff unrhyw un, heb fod ganddynt reswm digonol, ymdrochi na nofio mewn unrhyw ddyfrffordd heblaw am lecyn a neilltuwyd yn benodol ar gyfer ymdrochi a nofio.

### **Sglefrio ar Rew**

27. Ni chaiff unrhyw un gamu ar ddyfrffordd wedi rhewi na rhoi eu pwysau arni.

### **Cychod Model**

28. Ni chaiff unrhyw un hwylio cwch

### **Archery**

23. No person shall engage in the sport of archery except in connection with an event organised by or held with the written consent of the Council.

### **Field Sports**

24. No person shall throw or put any javelin, hammer, discus or shot except in connection with an event organised by or held with the written consent of the Council or on land set aside by the Council for the purpose.

### **Golf**

25. No person shall drive, chip or pitch a hard golf ball except in an area which by a notice placed by the Council has been set aside for use as a golf course, golf driving range, golf practice area or putting course.

## **PART 5**

### **Waterways**

Interpretation of Part 5

In this Part:

"boat" means any yacht, motor boat or similar craft but not a model or toy boat;

"power-driven" means driven by the combustion of petrol vapour or other combustible substances;

"waterway" means any river, lake, pool, or other body of water, and includes any fountain.

### **Bathing**

26. No person shall without reasonable excuse bathe or swim in any waterway except in a designated area for bathing and swimming.

### **Ice Skating**

27. No person shall step onto or otherwise place their weight upon any frozen waterway.

### **Model Boats**

28. No person shall operate a power-

### **Pysgota**

30. Ni chaiff unrhyw un fwrw rhwyd na llinell i unrhyw ddyfrffordd i ddal pysgod, neu unrhyw anifail arall heblaw mewn llecyn penodol ar gyfer pysgota.

### **Llygru dyfrffyrdd**

31. Ni chaiff unrhyw un lygru na baeddu unrhyw ddyfrffordd.

### **Rhwystro Dyfrffyrdd**

32. Ni chaiff unrhyw un achosi i lif unrhyw ddraen na dyfrffordd ar y tir gael eu rhwystro, eu dargyfeirio neu eu hagog a'u cau neu fel arall symud na gweithio unrhyw lifddor nac chyfarpar cyffelyb.

## **RHAN 6**

### **Awyrennau Model**

Dehongli Rhan 6

Yn y Rhan hon:

"awyren model" yw awyren nad yw'n drymach na 7 cilogram heb ei thanwydd; ystyr "wedi'i phweru" yw wedi'i gyrru gan:

(a) losgi anwedd petrol neu sylweddau fflamadwy eraill;

(b) gyda gyriant jet neu roced, heblaw am fotor adweithiol sy'n cael ei yrru gan belen danwydd solet nad yw'r hirach na 2.54 centimetr; neu

(c) gan un neu fwy motor trydan neu nwy cywasgedig.

"rheolaeth radio" yw rheoli gyda signal radio o drosglwyddydd radio neu ddyfais debyg.

driven model boat on any waterway except in a designated area for model boats.

### **Boats**

29. No person shall sail or operate any boat, dinghy, canoe, sailboard, or inflatable on any waterway without the consent of the Council except in a designated area for the sailing or operation of boats.

### **Fishing**

30. No person shall in any waterway cast a net or line for the purpose of catching fish or other animals except in a designated area for fishing.

### **Pollution of waterways**

31. No person shall foul or pollute any waterway.

### **Blocking of watercourses**

32. No person shall cause or permit the flow of any drain or watercourse in the ground to be obstructed or diverted, or open, shut or otherwise move or operate any sluice or similar apparatus.

## **PART 6**

### **Model Aircraft**

Interpretation of Part 6

In this Part—

"model aircraft" means an aircraft which weighs not more than 7 kilograms without its fuel;

"power-driven" means driven by—

(a) the combustion of petrol vapour or other combustible substances;

(b) by jet propulsion or by means of a rocket, other than by means of a small reaction motor powered by a solid fuel pellet not exceeding 2.54 centimetres in length; or

(c) by one or more electric motors or by compressed gas.

"radio-control" means control by a radio signal from a wireless transmitter or similar device.

### **Gwaharddiad Cyffredinol**

### **PART 7**

#### **Other Regulated Activities**

##### **Trading**

34. No person shall without the written consent of the Council provide or offer to provide any service for which a charge is made.

##### **Excessive noise**

- 35 (1) No person shall, after being requested to desist by any other person in the ground, make or permit to be made any noise which is so loud or so continuous or repeated as to give reasonable cause for annoyance to other persons in the ground:
- (a) by shouting or singing; or
  - (b) by playing on a musical instrument; or
  - (c) by operating or permitting to be operated any radio, amplifier, tape recorder or similar device.
- (2) Byelaw 35(1) does not apply to any person holding or taking part in any entertainment held with the consent of the Council.

##### **Public shows and performances**

36. No person shall without the written consent of the Council hold or take part in any public show or performance.

## **RHAN 8**

### **Amrywiol**

#### **Rhwystyr**

40. Ni chaiff unrhyw un -

### **Aircraft, hang-gliders and hot-air balloons**

37. No person shall except in case of emergency or with the written consent of the Council take off from or land in the ground in an aircraft, helicopter, hang-glider or hot-air balloon.

### **Kites**

38. No person shall fly any kite in such a manner as to cause danger or give reasonable grounds for annoyance to any other person.

### **Metal detectors**

39. No person shall without the written consent of the Council use any device designed or adapted for detecting or locating any metal or mineral in the ground.

## **PART 8**

### **Miscellaneous**

#### **Obstruction**

40. No person shall—

(a) obstruct any officer of the Council in the proper execution of his duties;

(b) obstruct any person carrying out an act which is necessary to the proper execution of any contract with the Council; or

(c) obstruct any other person in the proper use of the ground.

### **Savings**

41. (1) It shall not be an offence under these byelaws for an officer of the Council or any person acting in accordance with a contract with the Council to do anything necessary to the proper execution of his duty.

(2) Nothing in or done under these byelaws shall in any respect prejudice or injuriously affect any public right of way through the

### **Removal of offenders**

42. Any person offending against any of these byelaws may be removed from the ground by an officer of the Council or a constable.

### **Penalty**

43. Any person offending against any of these byelaws shall be liable on summary conviction to a fine not exceeding level 2 on the standard scale.

### **Revocation**

44. The byelaws made by Aberconwy Borough Council on 26<sup>th</sup> of August 1994 and confirmed by the Secretary for State on 20<sup>th</sup> of December 1994 are hereby revoked.
