	Mitigating Factors
	 There is a lack of adequate access for disabled users to the Auditorium level which is on the first floor of this building. This is attested through complaints from disabled people about the

Sex	Although we have no access to specific user equality data obtained from local providers at this venue, a national survey undertaken by the Arts Council of Wales (2010) showed that in Wales, attendance at arts events including plays and other live performance is biased towards women and higher social grades. Those who attend arts events (excluding cinema) at least once per year include 83% of women (pg. 73). This information indicates that the closure could have an impact on women.
Age	According to the 2011 Census data for Conwy County Borough, 24.7% of the population of Conwy County Borough are aged 65 years or older. According to the ACW Arts in Wales Report, 2010, 70% of those aged 65 years or older attend some sort of art event (excluding cinema) at least once per year (pg. 73). This indicates that this decision could have an impact on older people. Anecdotal evidence suggests that a large proportion of audiences for some productions are older people. The 2010 Arts in Wales Survey (ACW) found that 88% of families and 83% of those aged 16-24 years attend an arts event (excluding cinema) at least once per year (pg. 73). Some of the performances at this venue, e.g. pantomimes, and performances by dance classes, are undertaken by (or aimed at) local children and young people, and often it is children or young people and their parents who come to watch them. Other events are targeted at families e.g. wrestling. All age groups would be affected by the decision to close.

They have also complained about the sub-standards facilities at the Auditorium.

Building, Fire Safety Audit and the Health and Safety Audit 2013 and previous

Have identified up to £607,500 spend required on the building over a period of 1-3 years of which £340,000 is required immediately including:

- Replace the lift that is over 30 years old, it has broken down numerous occasions and parts are difficult to source, replacement cost over £50k
- The highest category risk from the FRA to upgrade the fire detection system needs to be addressed, costs £20K

- Ongoing water penetration to building
- o Permanent improvements to the stage lighting systems are outstanding
- Poor visibility re: the lighting on the emergency exit stairway, which needs to be improved to meet the needs of the visually impaired.

Research or Comparative Information

Extensive communication with the then Civic Hall Auditorium users was undertaken in 2011 when the proposal to close the Auditorium was taken through the political process, the decision was deferred while discussion were ongoing with CIWB Conwy CUBE.

Arts Council of Wales (ACW) <u>Arts in Wales Survey</u> (2010) * rep. sample size of 7,323 adults resident in Wales (aged 16 and over). This shows 88% of the adult population in Wales normally either participate and/or attends any arts activities once a year or more.

Cabinet in September 2010 agreed the closure of the Auditorium as a saving as the budget had been overspent for many years. In a subsequent report in February 2011, the closure was postponed until community possibilities were exhausted. The authority has been working with CIWB Conwy Cube community initiative for the past 2 years with a view to the group taking over the management of the building. Since the end of 2010 over 20 project development meetings between CIWB Conwy Cube and CCBC have taken place chaired by the Head of Community Development Service and supported by CDS officers. The project group has included officers from Estates Management, ERF, Planning and Conservation, Finance, European Funding and Legal Services who have provided support and advice in advance of the Business Case now under review.

The group has presented a business case to the authority in August 2013; appraisal of its business case by officers has highlighted concern over the viability and sustainability of the proposals.
