**COUNCIL TAX DISCOUNT DISREGARD/EXEMPTION APPLICATION FOR HOSPITAL PATIENTS**

Schedule 1 (Paragraph 6) of the Local Government Finance Act 1992 specifies that a person shall be disregarded for the purposes of discount on a particular day if *“on that date he/she is a patient who has his/her sole or main residence in a hospital”*. *“Hospital”* means (a) a health service hospital within the meaning of the National Health Service Act 1977 or Section 108(1) (interpretation) of the National Health Service (Scotland) Act 1978; and (b) a military establishment at or in which medical or surgical treatment is provided for persons subject to military law, air force law or the Naval Discipline Act 1957.
