Ar 10 Mawrth 2015 cytunodd Cabinet Cyngor Bwrdeistref Sirol Conwy'r cynnig canlynol ar gyfer Ardal Bae Colwyn

- Terfynu Ysgol Babanod Glan y Môr o 31 Awst 2015
- Terfynu Ysgol Iau Pendorlan o 31 Awst 2015
- Sefydlu ysgol gynradd gymunedol cyfrwng y Saesneg ar safleoedd yr ysgolion presennol o 1 Medi 2015

Mae'r Awdurdod wedi ystyried y cynnig a'r sylwadau a gyflwynwyd ac wedi ymateb yn unol ag anghenion Cod Trefniadaeth Ysgol 2013. Wrth benderfynu'r cynnig, roedd y Cabinet yn fodlon bod:

- Manteision y cynnig yn glir ac wedi'u cynllunio'n dda a bydd ansawdd a safon yr addysg y bydd disgyblion yn ei gael yn parhau ac o leiaf yn cynnal y safonau presennol.

Mae'r rhesymau am y penderfyniad ynghylch y ffactorau a amlinellwyd yn y ddogfen ymgynghori yn unol â'r Cod Trefniadaeth Ysgol fel a ganlyn:

Bu Cyngor Bwrdeistref Sirol Conwy yn adolygu nifer y disgyblion presennol, cydraddoldeb ariannu disgyblion ac addaswyd i'r pwrpas yr adeiladau ysgol presennol yn yr Awdurdod.

Rheolwyd Ysgol Babanod Glan y Môr ac Ysgol Iau Pendorlan gan un pennaeth ers Medi 2011. Cytunwyd yn 2013 i'r ddwy ysgol gael eu cyfuno'n ffurfiol a byddai gwaith adeiladu i uno'r ddwy ysgol yn dilyn maes o law.

Ni fydd y cynnig yn newid dalgyrch presennol Ysgol Babanod Glan y Môr nac Ysgol Iau Pendorlan.

Dear Consultees

On Tuesday 10th March 2015 Conwy County Borough Council's Cabinet agreed the following proposal for the Colwyn Bay Area

- Discontinue Ysgol Babanod Glan y Mor as of 31st August 2015
- Discontinue Ysgol Iau Pendorlan as of 31st August 2015
- Establish a new English Medium Community Primary School on the current school sites as of 1st September 2015

The Authority have considered the Proposal, the comments and observations submitted, and have responded in accordance with requirements of the School Organisation Code 2013. In determining the Proposal, Cabinet were satisfied that:

- The advantages of the proposal were clear and well planned and that the quality and standard of education pupils will receive will continue to at least maintain current standards.

The reasons for the decision in respect to the factors outlined in the published Consultation Document in accordance with the School Organisation Code are as follows:

Conwy County Borough Council has been reviewing current pupil numbers, equality of funding for pupils and the fitness for purpose of current school buildings across the Authority.

Both Ysgol Babanod Glan y Môr and Ysgol Iau Pendorlan have been managed by one Headteacher since September 2011. It was agreed in 2013 for the 2 schools to formally amalgamate and that building works to join both school buildings together would follow in due course.

The proposal will not change the current catchment area for Ysgol Babanod Glan y Môr and Ysgol Iau Pendorlan.
