Yn ddiweddar mae Cyngor Bwrdeistref Sirol Conwy wedi cymeradwyo cynnig i ystyried cyfuno Ysgol Babanod Pemaenrhos & Ysgol Iau Tan y Marian.

Conwy County Borough Council has recently approved a proposal to consider the Amalgamation of Ysgol Babanod Penmaenrhos & Ysgol Iau Tan y Marian.

Bydd cyfarfod rhanddeiliaid yn cael ei gynnal i drafod y cynnig hwn ar Dydd Mercher 22ain Hydref 2014 o 4.00p.m. yn Neuadd Cymuned Ysgol Tan y Marian. Fe'ch gwahoddir i'w fynychu a bydd y sylwadau a wneir yn y cyfarfod hefyd yn cael eu hystyried yn yr ymgynghoriad.

Bydd y cyfnod ymgynghori yn cael ei gynnal rhwng 8fed Hydref a 18fed Tachwedd 2014 yn gynwysedig.

Rhaid cael yr holl sylwadau ynglŷn â'r cynnig erbyn 18fed Tachwedd 2014, sef diwrnod olaf yr ymgynghoriad.

Ar ddiwedd y broses ymgynghori bydd Cyngor Bwrdeistref Sirol Conwy yn penderfynu os ydynt am symud ymlaen ai peidio gyda'r cynnig i gau Ysgol Rhydgaled. Pe bai'r Cyngor yn penderfynu gwneud hyn, bydd cyfnod gwrthwynebu statudol o 28 diwrnod pan ellir cyflwyno gwrthwynebiad ysgrifenedig yn erbyn y cynnig. Bydd yr Awdurdod yn gwneud penderfyniad ar ddiwedd y cyfnod gwrthwynebu o 28 diwrnod boed gwrthwynebiad wedi'i dderbyn neu beidio o fewn y cyfnod statudol.

There are other ways in which you may submit your views and these are set out at the end of the Consultation Document.

A meeting of stakeholders will be held to discuss this proposal at Ysgol Tan y Marian Community Hall Wednesday, 22nd October 2014 from 4.00 p.m. You are welcome to attend and comments on the proposal made in the meeting will also be taken in to account in the consultation.

The consultation period runs from 8th October to 18th November 2014 inclusive.

All comments on the proposal must be received by the 18th November 2014, which is the last day of the consultation.

At the close of the consultation process Conwy County Borough Council will decide whether or not to proceed with the proposal to close Ysgol Rhydgaled. Should the Council decide to do so, then there is a statutory 28 day objection period during which time objections to the proposal may be made in writing.

Whether or not objections are received within the statutory period, the proposal will be determined by the Authority at the end of the 28 day objection period.
