Mae Ysgol Babanod Glan y Môr ac Ysgol Iau Pendorlan yn Ysgolion Cynradd Cymunedol Cyfrwng Saesneg a gynhelir yn bresennol gan Gyngor Bwrdeistref Sirol Conwy.

Cynhaliodd Cyngor Bwrdeistref Sirol Conwy gyfnod ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Cyngor Bwrdeistref Sirol Conwy fydd yr awdurdod derbyn. Y rhif derbyn cyhoeddedig arfaethedig ar gyfer yr ysgol wedi'i chyfuno yw 52 ymhob grŵp blwyddyn. Nifer y lleoedd meithrin yn yr ysgol newydd fydd 28. Maint yr ysgol newydd fydd 316.

School Standards and Organisation (Wales) Act 2013

Notice is hereby given in accordance with Section 41 & 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code that Conwy County Borough Council, having consulted such persons as required, propose to:

- **Discontinue Ysgol Babanod Glan y Môr, Greenfield Road, Colwyn Bay Conwy, LL29 8ET &**
- **Discontinue Ysgol Iau Pendorlan, Greenfield Road, Colwyn Bay, Conwy, LL29 8ET**
- **Establish a new English Medium Community Primary School to be maintained by Conwy County Borough Council on their current sites, Greenfield Road, Colwyn Bay, Conwy, LL29 8ET for boys and girls aged 3 to 11 year olds.**

Both Ysgol Babanod Glan y Môr & Ysgol Iau Pendorlan are English Medium Community Primary Schools currently maintained by Conwy County Borough Council.

Conwy County Borough Council undertook a period of consultation before deciding to publish this proposal. A Consultation Report containing a summary of the issues raised by consultees, the proposers responses and the views of Estyn is available on the Conwy County Borough Council, Education Services website: www.conwy.gov.uk/colwynbayarea1

It is proposed to implement the proposals on 31st August 2015.

There will be no change to the current catchment area for Ysgol Babanod Glan y Môr and Ysgol Iau Pendorlan.

Pupils currently attending Ysgol Babanod Glan y Môr and Ysgol Iau Pendorlan would be guaranteed a place within the all-through school. Pupils will no longer be required to apply to transfer from infants to juniors and will enter the school at Reception through to Year 6 before continuing with their Secondary education.

Conwy County Borough Council will be the admission authority. The proposed published Admission Number for the amalgamated school is 52 in each year group. The number of nursery places at the new school will be 28. The new school's capacity will be 316.

Transport will only be provided in accordance with Conwy County Borough Council's Home to School Transport Policy.

Within a period of 28 days after the date of publication of this proposal, that is to say by **8th February 2015** any person may object to the proposal.

Explanatory Note

1. The Council is proposing to amalgamate Ysgol Babanod Glan y Môr and Ysgol Iau Pendorlan. This will result in the closure of both schools as of the 31st of August 2015 and the new amalgamated school opening on the 1st September 2015 on their current sites.
2. The reasons for this proposal were set out in the Consultation Document published 8th October 2014.
3. Conwy County Borough Council has been reviewing current pupil numbers, equality of funding for pupils and the fitness for purpose of current school buildings across the Authority.
4. A copy of the Conwy County Borough Council's School Admissions Policy and Home to School Transport Policy are available on the County's website.
5. This notice marks the start of a 28 day Objection Period from **12th January to 8th February 2015** and sets out the address to which objections in writing may be submitted.
