Bydd y sesiynau'n cael eu cynnal ar -


- Dydd Mawrth 13^{eg} Hydref, 3yp–4.30yp – Ysgol Tal y Bont

The sessions will be held on the following dates and times –


- Tuesday 13th October, 3pm–4.30pm – Ysgol Tal y Bont
