NOTICE IS HEREBY GIVEN in accordance with Section 41 and 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code 2018 that Conwy County Borough Council, having consulted such persons as required, propose as indicated below:

1. Conwy County Borough Council propose to establish a new English Medium, mixed sex school for Mochdre to be maintained by Conwy County Borough Council on the sites of the existing Ysgol Babanod Mochdre and Ysgol Cystennin schools, for children aged 3-11.

As a result of the proposals outlined above:

2. Conwy County Borough Council propose to discontinue YSGOL BABANOD MOCHDRE, STATION ROAD, MOCHDRE, LL28 5EF. The school is currently maintained by Conwy County Borough Council. It is proposed to implement this proposal on 31 August 2024.
3. Conwy County Borough Council propose to discontinue YSGOL CYSTENNIN, THE OLD HIGHWAY, MOCHDRE, LL28 5AU. The school is currently maintained by Conwy County Borough Council. It is proposed to implement this proposal on 31 August 2024.

It is proposed to implement the proposal on 1st September 2024.

Pupils currently attending the two discontinued schools will automatically be transferred to the new proposed school unless parents/carers request otherwise.

The proposed new school will be a community school.

Conwy County Borough Council will be the admission authority.

NODYN ESBONIADOL

Y cynnig yw cyfuno Ysgol Babanod Mochdre ac Ysgol Cystennin (ysgol iau) yn ffurfiol.

Mae'r ysgolion wedi'u ffedereiddio'n ffurfiol ers Mawrth 2017. Mae ffedereiddio'n drefniant ffurfiol a chyfreithiol sy'n golygu bod yr ysgolion yn rhannu rhai trefniadau llywodraethu penodol a chorff llywodraethu, dan arweiniad y Pennaeth ar y pryd.

Bydd y cynnig i gyfuno Ysgol Babanod Mochdre ac Ysgol Cystennin yn golygu cau'r ddwy ysgol yn ffurfiol ac yna agor ysgol newydd.

Byddai'r ysgol arfaethedig yn aros ar y ddau safle ar wahân presennol, dan arweiniad un Pennaeth ac un bwrdd llywodraethu, ond gyda'r un strwythur rheoli, datganiad o fwriad, gwerthoedd, logos, gwisg, polisiau a gweithdrefnau.

EXPLANATORY NOTE

The proposal is to formally amalgamate Ysgol Babanod Mochdre (Infants) and Ysgol Cystennin (Juniors).

The schools have been formally federalised since March 2017. This is a formal and legal arrangement by which the schools share certain governance arrangements and have a single governing body, under the leadership of the existing head teacher.

The Proposal to amalgamate Ysgol Babanod Mochdre and Ysgol Cystennin will mean the formal closure of both schools followed by the opening of a new school.

The proposed new school would remain located on two separate sites, under the leadership of one Head teacher and board of governors but with a unified management structure, mission statement, school values, logos, uniform, policies, and procedures.

The reasons for this proposal and factors considered were set out in the Proposal Document, approved by Cabinet 13th June 2023.

This notice marks the start of a 28-day Objection Period from 7th November to 5th December 2023 and sets out the address to which objections in writing may be submitted.
