Caerhun Area Primary School Transport Assessment Scoping Letter

1. Introduction

Opus International Consultants (UK) Ltd has been commissioned by Pure Residential and Commercial Limited to prepare a Transport Assessment for the proposed 120 place Caerhun Area Primary School in Conwy, Wales to replace Ysgol Trefriw, Ysgol Dolgarrog, and Ysgol Tal Y Bont. The proposed Primary School will be built on the existing school site at Dolgarrog which borders the B5106 Conwy Road that connects the three existing schools. It is anticipated that a full planning application for the scheme will be submitted week commencing 24th May 2017.

It is noted that Conwy County Borough Council (CCBC) have outlined the requirements for a Transport Assessment in an email dated 30th March 2017, which required the following to be included within any report:

- 1. Details on all current and proposed staff parking (teachers / admin / visitors / support staff etc.) at this site;
- 2. The TA must assess vehicle movements to the site from both north and south of the proposed development detailing the split;
- 3. The TA must clarify the volume of traffic on the school being at capacity;
- 4. The TA must include a review of the accident record for the most recently available 5 year period immediately around the proposed development site and incorporate all above detailed junctions including their routes to the proposed development;
- 5. TA must take account of any approved but as yet unbuilt committed developments within the traffic flow calculations within the TA work;
- 6. The TA must include an appraisal of the scheme in the context of current local and national transport planning policy;
- 7. The TA must include a detailed description of the existing conditions around the site and the local highway network;
- 8. The TA must include a review of the accessibility of the site by non-motorised modes and a review of facilities in the vicinity of the development site. This will include route assessments of non-motorised users to the proposed school from local residential settlements, other amenities,

bus stops, train station and the like. Review must also take into account Active Travel Wales ERM and INM routes and align with ATW requirements;

- 9. The TA must include a full appraisal of the proposed development and its intended operation, including details of the level of proposed parking facilities (for cars, motorbikes, cycles etc.), servicing arrangements and swept path analysis plans (as appropriate). Parking levels and dimensions of different types of bays must adhere to SPG LDP2, refuse vehicle and fire tender swept paths to be included;
- 10. If any off-site works are required to make the development satisfactory in highway terms, the TA must identify them and put forward suitable plans for consideration;
- 11. A qualitative review of nearby bus stop usage and routes must be included in the TA.

This Transport Scoping Letter has been prepared in order to set out our report structure and methodology for undertaking the Transport Assessment which aims to address each point raised above. This approach was agreed with CCBC to be acceptable on 7 April 2017.

2. Transport Assessment Structure

The TA will be submitted to support the proposals at the application stage. The TA will investigate the transport issues associated with the proposed development. The structure and detail in the TA will be as follows:

- Section 1 will provide a brief overview of the site and sets out the content of the TA
- Section 2 provides a review of the policy context
- Section 3 describes the existing site and highway conditions;
- Section 4 outlines the development proposals;
- **Section 5** assesses the trip generation:
- **Section 6** considers the potential impacts of the development proposals;
- **Section 7** outlines the Transport Implementation Strategy
- **Section 8** provides a summary of the Transport Assessment

3. Methodology

Further information on the content of the TA is discussed below.

Section 2 – Policy Context

The TA will include a section that will focus on local and nation transport planning policy and consider how the policy effects access to education. The policies that will be considered include:

- Planning Policy Wales, Edition 8 (January 2016);
- Planning Policy Wales Technical Advice Note 18: Transport (March 2007);
- Active Travel (Wales) Act, 2013;
- Wales National Transport Plan (March 2010);
- North Wales Regional Transport Plan (September 2009);

- North Wales Joint Local Transport Plan (2015);
- Conwy County Borough Council Adopted Local Development Plan (2007 2022)

Section 3 – Existing Site and Highway Conditions

Site Visit

A site visit will be undertaken during school term times in order to review the local area, the site visit will take account of:

- Speed limits along the surrounding highway network;
- Standard of footways and uncontrolled crossing points;
- Location of controlled pedestrian/cycling crossing points;
- Cycling facilities within the vicinity of the school;
- Existing traffic regulation orders in the vicinity of the school;
- Pedestrian, vehicle and cyclist entry points.

Existing School Operation

The TA will include a site location plan and provide a description of the current school operation, staff and pupil details and existing parking arrangements, which will be obtained from the applicant and also from site observations. It will also highlight details of the Ysgol Trefriw and Ysgol Tal Y Bont, which are also to be relocated to the proposed developments site location.

Existing Highway Network

Details regarding the local highway network will be provided. This will include but is not limited to, the condition of the highway network, speed limits, parking restrictions, lighting, access and any pedestrian crossings. As part of this section details on the vehicle movements along B1506 Conwy Road will be analysed. In order to capture this information it is proposed to undertake an Automatic Traffic Count (ATC) outside the existing Ysgol Dolgarrog. It is proposed that the ATC is positioned to the south of the proposed site on the B5106 Conwy Road. The proposed location for the ATC is shown in Figure 1.



Figure 1: Proposed ATC location

The ATC data will be used to establish the existing traffic volumes and speeds and will be analysed to highlight any safety concerns on the surrounding highway network such as speeding vehicles

Sustainability Data

The TA will consider the accessibility of the site by non-motorised methods. An audit of the local cycle and pedestrian network adjacent to the site will be undertaken to assess existing opportunities to walk and cycle to the site from existing residential location and surrounding amenities.

As well as an appraisal of the existing pedestrian and cyclist provision an examination of the local public transport services will be undertaken. As requested by CCBC, a review of the bus stop and route usage will be undertaken, this will be primarily carried out by on site observations but we will also contact the relevant bus companies to obtain patronage data. However, we are aware that this information is normally commercially sensitive.

This section will also take account of policy set out in Active Travel Wales.

Personal Injury Collision Data




Figure 2: Proposed PIC Extent

It is stated in the comments from CCBC that the TA must include a review of the accident record for the most recently available 5 year period immediately around the proposed development site. The TA will analyse Personal Injury Collision (PIC) data from the most recently available 5 year period. The proposed extent of data analysis is shown in Figure 2.

The PIC data will be analysed and any patterns in the data that could present a safety concern will be discussed within the TA.

Section 4 – Development Proposals

This section will describe the proposed development composition and outlines the operation of the development.

Proposed Development Composition

Details regarding the development proposals will be included within the TA, this will include opening hours, staff levels, and pupil numbers and will include the Architects layout. It is anticipated that this information will be provided to Opus by the applicant.

Proposed Development Access

The TA will set out details regarding the proposed vehicular and pedestrian/cycle access arrangements and provide justification as to why the proposed arrangements are suitable to serve the development. A plan illustrating visibility splays at the access arrangements will be provided, as appropriate.

Proposed Car Parking Provision

The proposed car parking provision will be provided and it is anticipated that this will be based upon the guidance set out in Conwy Development Plan 2007-2022. Opus has been informed by TACP Architects Ltd that at this stage parking will consider the following:

- 1 per 2 full time staff (Nursery and Crèche);
- 1 for each full time staff (Reception/Infants/Juniors);
- 1 per ancillary staff (Reception/Infants/Juniors)
- 3 visitor spaces (Reception/Infants/Juniors)
- Disabled space 5% Total Car Park Capacity.

Proposed Cycle Parking Provision

It is anticipated that the proposed cycle parking provision will be provided based upon the guidance set out in Conwy Development Plan 2007-2022. Opus has been informed by TACP Architects Ltd that at this stage parking will consider the following:

- 1 stand per 5 staff
- 1 stand per 20 children

Servicing Arrangements

Details on the delivery and servicing requirements will be included within the TA and swept paths for servicing and emergency vehicles will be provided.

Section 5 – Traffic Generation and Distribution

Trip Generation

This section outlines the level of trips associated with the existing development and predicts the level of trips associated with the proposed development. Opus will seek to liaise with the existing Ysgol Dolgarrog in order to ascertain whether any travel to school information is available in order to provide first principles assessment of how existing and future pupils may travel to the Ysgol Caerhun development.

However, if this information is unavailable a TRICS assessment will ultimately be applied. The TRICS database has been interrogated for comparable sites and two relevant multi-modal surveys in the category '04 – Education – A – Primary' have been identified in order to generate a trip rate for the existing and proposed school. It should be noted that the range of students in the two surveys was between 147 and 184 which is higher than both the existing and proposed student numbers at the site.

The TRICS reports are included at **Appendix A** and the generated peak hour trips by mode are summarised in Table 1 for the existing school, which currently comprises 90 pupils and the respective number of trips for the proposed school, which is seeking capacity for up to 120 pupils are summarised in Table 2.

The impacts of the additional trips on the highway network will be included within Section 6 of the TA.

Trip Distribution

The predicted number of vehicle trips generated by the proposed development will be distributed at the access junction on a pro rata basis, which will be derived based on the ATC data.

Committed Development

Opus has undertaken a search of planning applications within the vicinity of the site in order to ascertain any committed developments that will need to be considered as part any application. Opus has identified one application 0/40530, which relates to the Surf Snowdonia and has permission for a mixed use

regeneration scheme at the Former Aluminium Work on Conwy Road. As part of the application a Transport Assessment was provided and trip generation numbers provided as part of this report will be included and analysed as part of any Transport Assessment to support the Ysgol Caerhun development.

Car Parking Survey

A car parking survey will be commissioned to be undertaken in order to determine the extent of on-street parking that occurs within the vicinity of the school during drop off and pick up times.

It is understood that Conwy County Council propose to provide a road enhancement scheme to the B5106. This will include the narrowing of the road, reduction of speed from 30mph to 20mph outside the school, and the creation of laybys to serve as a drop off zone for pupils and a stopping area for delivery vehicles.

The survey will be used to demonstrate the impact of these road enhancements to trips generated and on-street parking at the drop off and pick up times. If it is found that additional issues may occur, additional mitigation measures will be suggested.

Section 6 – Impacts of Development

This section will provide an assessment of the potential impact of the proposed Ysgol Caerhun development. The impacts on the following will be considered:

- Operation of Conwy Road considering the ATC and committed development, the impact will be consider on a percentage increase basis;
- Parking considering the on-street car parking results and the proposed road enhancement scheme;
- Pedestrian and cycle access this will consider the site observation and likely number of walking and cycling trips;
- Public Transport considering the existing bus usage details and the likely number of public transport trips.

If a detrimental impact is found as result of the development then the TA will identify mitigation measures (e.g. off-site works or travel plan measures) that may be required to make the development satisfactory in highway terms.

Section 7 – Transport Implementation Strategy

A chapter will be provided as part of the Transport Assessment, which includes:

- Details of any improvements to the safety of walking and cycling routes, as appropriate;
- Car access restrictions around schools;
- Details regarding cycle parking levels and storage; and
- Framework for future schools travel planning activity.

It should be noted that a Travel Plan for the Ysgol Caerhun development will be provided as a separate document.

4. Summary

A Transport Assessment will be provided in support of the application for the proposed Caerhun Area Primary School in Conwy, Wales. The TA will assess the impact of the development on the local highway network with regards to the accessibility of the site. The existing conditions of the site and proposed developments will be considered as part of the TA. PIC data will also be assessed for the vicinity of the site. Existing and proposed trip generations will be included within any TA and the impacts of the development will be considered and if any detrimental impact is concluded then mitigation measures will be suggested, as appropriate.
