Dear Parents/Carers

You will be aware following the Welsh Government's announcement on 19th October that a two week "firebreak" lockdown comes into force at 6pm on Friday 23rd October 2020. Welsh Government have said repeatedly that children would be their top priority if further restrictions are needed, and as a result have looked to keep disruption to education to a minimum.

We hope that the following information will help explain the arrangements that will be in place in Conwy to help minimise any disruption to your child/children's education.

School Attendance Arrangements

The following groups of pupils will return to school as normal after half term:

- All Primary School pupils
- All Ysgol y Gogarth pupils
- Secondary age pupils in Years 7 and 8
- Pupils attending a Pupil Referral Unit (including Years 9 and above)
- *Pupils sitting GCSEs and University entrance exams in November will be able to do so at their school/college.*

All other pupils will continue their learning from home the week beginning November 2nd.

Individual schools may also contact you directly about arrangements for vulnerable learners in Years 9 and above.

Distance Learning

Distance learning and support will be made available to all pupils in Years 9 and above who are not returning to school immediately after the half term break. Guidance on the minimum expectations for learning is being issued by Welsh Government.

Work is also continuing to ensure that all pupils have access to digital equipment so that they can access distance learning. Please contact your child's school directly if you need any support with this or have any questions.

Distance learning arrangements will vary between schools so please contact your school directly after the half term break should you require further guidance or support.

Children in years 9-13 who may need additional support

Schools are working to identify the children who would exceptionally benefit from additional support. This will be done with children and families, so their needs can be understood and delivered through the most appropriate support. These children will be regularly reviewed and monitored by the individual schools. It will be considered how risks could be mitigated through the most appropriate support in order to ensure all children are safe, seen, heard, nurtured and developed.

Transport

If your child receives school transport by Conwy County Borough Council and have been told that their group* still needs to attend school during the Welsh Government 'firebreak' then please contact your taxi firm to arrange. If you are unsure which firm transports your child please contact Home2school team on 01492 577899.

School buses will be running as normal.

(*Secondary schools will re-open after the half-term for children in years 7 and 8. Pupils will be able to come in to take exams)

Free School Meals

Free school meal arrangements have already been put in place for half term and will continue for pupils in year 9 and above for a third week. Pupils in Conwy who are eligible for free school meals will receive direct payments for the two week half term break and this will be extended for an additional week for those learners in Years 9 and above.

Payment will be made in to Parents'/Carers' Bank accounts on 5/11/20.

We understand that this continues to be a concerning time for everyone, and we want to assure you of our commitment to working together to keep your children, their families and our community safe in Conwy.
