Path Diversion Order 2020

The above Order made on 18 August 2020, under Section 257 of the Town and Country Planning Act 1990, will divert that section of public footpath No 50 in the Community of Conwy commencing from grid reference SH 77029 77039 to the east of the Henryd community boundary to the north east of Bryn Bychan, continuing in a south east direction to a point south of Parc Sychnant at grid reference SH 77128 77015.
