**The County Borough of Conwy (Access Road (off Conway Road) Llandudno Junction)**  
**(Prohibition of Waiting) Order 2020**

On 29 September 2020 the Conwy County Borough Council made the above-named Order under Sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which is to prohibit the waiting of vehicles at any time in the lengths of road specified in the Schedule below.

Exceptions are provided in the Order to permit waiting for the purposes of alighting, boarding, loading, unloading and works of maintenance, repair and the like. Exceptions are also provided in the Order to allow vehicles displaying both a disabled person's badge and a disabled person's parking disc

A copy of the Order and plan which will come into operation on 12 October 2020 may be examined on the Council website.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date hereof apply to the High Court for this purpose.
