**The County Borough of Conwy**  
**(A547 Abergele Road, Old Colwyn - Speed Limit) Order 2022**

Conwy County Borough Council has made the above-named Order under Sections 82(2) 83(2) 84(1) and 84(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which will prohibit any person from driving any motor vehicle at a speed exceeding the speed limit on the length of restricted road specified in the Schedule below.

The previously made Order named Conwy County Borough Council (A457) Speed Limit Consolidation Order 2003 will be revoked in so far only as it affects the length of road described in the Schedule below

A copy of the Order, which will come into operation on 1 February 2022 and a map showing the length of road to which the Order relates may be examined on the Council's website.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.
