**The County Borough of Conwy (B5106 Conway Road Tal y Bont/Dolgarrog)
(Prohibition and Restriction of Waiting) Order 2019**

The Conwy County Borough Council proposes to make an Order under Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which will –

1. Prohibit the waiting of vehicles at any time in the lengths of road specified in Schedule 1.
2. Limit waiting time to 15 minutes (Monday to Friday 8am-6pm) with no return within 60 minutes in the lengths of road specified in Schedule 2.
3. Designate the length of road specified in Schedule 3 as parking for school buses only.

Exceptions will be provided in the proposed Order to permit waiting for the purposes of alighting, boarding, loading, unloading and works of maintenance, repair and the like. Exceptions will also be provided in the proposed Order for vehicles displaying both a disabled person's badge and a disabled person's parking disc.

A copy of the proposed Order together with a map showing the lengths of road to which the proposed Order relates and a statement of the Council's reasons for proposing to make the Order may be examined at Llanrwst Library and at the offices of the Head of Law and Governance, Bodlondeb, Conwy during normal opening / office hours and on the Council website.

Objections to the proposed Order, together with the grounds on which they are made should be sent in writing to the Traffic Section, Environment Roads and Facilities Mochdre Offices Conway Road Mochdre Colwyn Bay LL28 5AB or to traffic@conwy.gov.uk by 2 August 2019.
