Mae Cyngor Bwrdeistref Sirol Conwy (y cyfeirir ato o hyn ymlaen fel “y Cyngor”) wrth ddefnyddio’i bwerau dan Adrannau 32 a 35 a Rhan IV o Atodlen 9 o’r Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (y cyfeirir ati o hyn ymlaen fel “y Ddeddf 1984”) a phob pŵer arall sy’n galluogi ac ar ôl ymgynghori â Phrif Swyddog yr Heddlu yn unol â Rhan III Atodlen 9 Deddf 1984, yn gwneud y Gorchymyn canlynol:-

1. Bydd y Gorchymyn hwn yn dod i rym ar dwy fil a phump ar hugain a gellir ei ddyfynnu fel “Gorchymyn Cyngor Bwrdeistref Sirol Conwy (Lleoedd parcio oddi ar y stryd) 1997 (Diwygiedig Rhif 1) Gorchymyn 2025 Mostyn Broadway Maes Parcio Coetsys a Cheir Llandudno”.

2. Yn y Gorchymyn hwn: -

(a) Mae Atodlen 7 o’r Gorchymyn Cyngor Bwrdeistref Sirol Conwy (Lleoedd Parcio oddi ar y stryd) 1997 yn cael ei ddiwygio drwy hyn, y bydd ei effaith yn ychwanegu prisiau newydd ac ychwanegu at y dosbarth cerbydau a ganiateir ar Maes Parcio Coetsys a Cheir Mostyn Broadway Llandudno fel y dangosir yn yr Atodlen isod

Park Llandudno

The Conwy County Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, ("the Act of 1984"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into operation on two thousand and twenty five and may be cited as "Conwy County Borough Council (Off-street Parking Places) Order 1997 (Amendment No 1) Order 2025 - Mostyn Broadway Coach and Car Park Llandudno".

2. In this Order:-

Schedule 7 of the The County Borough of Conwy (Off-street Parking Places) Order 1997 is hereby amended, the effect of which will introduce new charges and add to the class of vehicles permitted in the Mostyn Broadway Coach and Car Park as detailed below.

3. The prohibition and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
