**The County Borough of Conwy (Caerhun and Bro Garmon)**  
**(Prohibition of Driving) Order 2022**

The Conwy County Borough Council proposes to make an Order under Sections 1 and 2 of the Road Traffic Regulation Act 1984 ("the Act"), the effect of which is to prohibit motor vehicles to proceed (except for access) in the roads shown in the Schedule below. Exceptions are provided in the Order to permit entry for the purposes of works of maintenance, repair and the like.

A copy of the proposed Order together with a map showing the lengths of road to which the Order relates and a statement of the Council's reasons for proposing to make the Order may be examined on the Council website. Requests for paper copy documents can be made by contacting 01492 575337.
