Mandatory Learning Plan for Covid-19 Intervention

This is a mandatory learning plan for new staff in the social care sector, employed as a result of the response to COVID-19 action planning. The following learning modules have been put together as a minimum intervention due to the current situation and face to face training being suspended. However please note that all new employees will be expected to complete further training once restrictions are lifted.

Employees will need to work through the modules listed below and once completed sign the document along with their line Manager to confirm they have completed the learning and understood its content.

The full training package will take approximately 7hrs to complete and will require access to a laptop, tablet or desktop computer.

Course Includes:

Module	Description
Introduction to Moving, Handling and the Law	Why training is important, moving and handling activities, potential injuries, legislation and employer and employee responsibilities.
Risk Assessment	Generic assessments, individual assessments, identifying the hazards, deciding who may be harmed, personalising the risk assessment, controlling the risks and recording and reviewing the assessment.
